DURING FISCAL YEAR 2017 (THE 2016-2017 SEASON), CAM PRESENTED TWENTY EXHIBITIONS, FEATURING PRESCIENT AND SEMINAL WORK BY EMERGING AND ESTABLISHED ARTISTS, RANGING FROM PAINTING AND SCUPTURE TO SOCIAL PRACTICE AND PARTICIPATORY ART, WITH FOUR SITE-SPECIFIC INSTALLATIONS THAT TRANSFORMED THE FACADE AND COURTYARD.
